125th Anniversary of St. Pauli Church

Mark Your Calendars!

2020 is the year in which St. Pauli will celebrate 125 years of service to the Lord.

A two-day celebration event will be held the first weekend in August: Saturday and Sunday, August 1-2

A special service will be conducted on January 5, 2020 to commemorate the formal organization of the church and adoption of the constitution.

The first meeting was held in the Braaten schoolhouse (the first log school building) on January 3, 1895. Reverend Evenson was chairman and Pete Paulson was secretary. The constitution of the Norwegian Evangelical Lutheran Church was read and adopted. St. Pauli was chosen as the name for the new congregation which was to be served by Reverend I. T. Aastad, pastor of what is now Trinity Lutheran Church in Thief River Falls.

June 26, 2019

The St. Pauli Women of the ELCA met on June 26^{th} at Valley Home at 7 pm with nine members present.

President Jan Strandlie called the meeting to order and led us in devotions and prayer. She shared an article about conditions in border facilities for refugees. She urged members to contact our legislators to voice concerns and provided their names and contact information.

Secretary's report was read by Cindy Cedergren in Sharon Bugge's absence. It was approved as read.

The treasurer's report was given by Faye Auchenpaugh and was approved as read.

Jan read various correspondence from Project 24 in Kenya, Lutheran Social Services, and Skip and Talli Swanson, along with a thank you gift of \$200 from them for serving the lunch on June 16th.

Jan reported that we can still donate to the Child Safety Council for this year and be listed as a donor. It was agreed at last month's meeting to donate \$75.00. The Rev. Bill Tesch Elected Bishop of Northwestern Minnesota Synod

After five ballots, more than 400 Rostered Leaders and Lay Voting Members of the Northwestern Minnesota Synod of the Evangelical Lutheran Church in America (ELCA) have called Pastor Bill Tesch as its Bishop-Elect.

"I'm incredibly excited!" Bishop-elect Tesch said. "This is an amazing call, it's an amazing honor. I'm deeply humbled and I'm still processing it and will be doing so for a while. I'm grateful to God and to the people of this synod for this opportunity."

"This is the beginning of an exciting collaboration with the people of this synod as we explore how to be the church in the twenty-first century, how to reach people with the exciting good news of the gospel of Jesus Christ," Bishop-Elect Tesch says. "I'll be collaborating with the people of this synod to explore how we can raise up leaders, both rostered and lay leaders, across our synod to serve congregations, especially our rural congregations. I'll also be exploring how we can collaborate and reach out to people who have experienced marginalization, including our Native American brothers and sisters."

In the ELCA, Synod

Bishops serve six-year terms. According to the Synod's Constitution, the bishop is elected by the Synod Assembly by ecclesiastical ballot. The fifth and final ballot results were: 265 Pastor Bill Tesch, Sioux Falls, SD; 161 Pastor Genelle Netland, Bemidji, MN. A simple majority of votes was needed on this final ballot.

Pastor Tesch's personal mission statement is: "A Follower of Jesus: Creating Gospel Collaborations with Faithfulness, Authenticity and Love."

Tesch, who grew up in Green Bay, Wisconsin, has been serving as the Director of Evangelical Mission and Associate to the Bishop in South Dakota since 2007. He is also serves as a Chaplain in the United States Military (South Dakota Air National Guard) and is a senior leader holding the rank of Colonel. Pastor Tesch's responsibilities with the military will come to a close near the end of 2020.

Pastor Tesch has served in South Dakota since his Ordination in 1989. Before his election to Bishop, he served first as Pastor of a two-point rural and small- town congregation (St. Paul and St Peter in Humboldt and Orland) and then as the Founding Pastor and later Sr. Pastor of Messiah New Hope in Sioux Falls, and finally as Director of Evangelical Mission and Associate to the Bishop on the South Dakota Synod staff.

Education: Pastor Tesch is a graduate of the University of Wisconsin Madison and Luther Seminary as well as the USAF Air War College, Air Command and Staff College, the Air Force Basic Chaplain's Course and Officer's Training School.

He is married to Chris Tesch who teaches Nursing at the University of South Dakota. He and Chris have two adult children. In his spare time Pastor Tesch enjoys exercise, hunting, fishing, book club, entertaining friends and family... and a host of other hobbies for which he says he really has no time!

The new bishop will assume office on September 1, 2019. Reverend Dr. Lawrence Wohlrabe, who began his ministry as NW MN Synod Bishop on September 1, 2007, is retiring effective the same date. Bishop Tesch's installation will be held September 8, 2019, at Trinity Lutheran Church (210 7th St S) in Moorhead.



Presiding Bishop Elizabeth Eaton Re-Elected

The Rev. Elizabeth A. Eaton was re-elected presiding bishop of the Evangelical Lutheran Church in America (ELCA) Aug. 6 at the 2019 ELCA Churchwide Assembly.

On the first ballot, 897 votes were cast and 670 votes were needed for election. Eaton received 725 votes, which is 81.19% of the vote.

Eaton is the first ELCA presiding bishop to win re-election on the first ballot. She was elected to a first term as presiding bishop at the 2013 ELCA Churchwide Assembly in Pittsburgh.

What Might it Mean to Be a Sanctuary Church Body?

On Wednesday, August 7, 2019, voting members of the ELCA Churchwide Assembly adopted a memorial that included an amendment "to declare the Evangelical Lutheran Church in America a sanctuary church body."

CA19.03.11 Churchwide Memorial Declaring the ELCA a Sanctuary Church Body

To receive with gratitude the memorial from the Metropolitan New York Synod concerning sanctuary;

To reaffirm the long-term and growing commitment of this church to migrants and refugees and to the policy questions involved, as exemplified most recently in the comprehensive strategy "Accompanying Migrant Minors with Protection, Advocacy, Representation and Opportunities" (AMMPARO);

To recognize that the ELCA in congregations, synods and the churchwide organization are already taking the actions requested by this memorial; and

To request that appropriate staff on the AMMPARO team, LIRS, and the Domestic Mission, Global Mission, and Mission Advancement units review the existing strategies and practices by the five current sanctuary synods and develop a plan for additional tools that provide for education and discernment around sanctuary;

To declare the Evangelical Lutheran Church in America a sanctuary church body; and

To request the ELCA Church Council, in consultation with the appropriate churchwide units and offices, provide guidance for the three expressions of this church about what it means to be a sanctuary church body and provide a report to the 2022 Churchwide Assembly.

Unfortunately this action was picked up by a national cable news network that broadcast a five-minute "discussion" by three panelists, none of whom were present at the Churchwide Assembly, nor are they members of the ELCA or authorized to speak on behalf of the ELCA. The broadcast conveyed misinformation about the Assembly's action, implying that ELCA congregations would simply ignore U.S. law, which is not true. Also, a panelist implied that undocumented immigrants carry disease and pose a public health risk, which is also not true.

So what might it actually mean for our ELCA to be a "sanctuary church body?" In response to this legitimate question, ELCA leaders familiar with our church's strategy for engaging issues around immigration and refugees have offered the following information:

- In its simplest form, becoming a sanctuary denomination means that the ELCA is publicly declaring that walking alongside immigrants and refugees is a matter of faith. The ELCA Churchwide Assembly, the highest legislative authority of the ELCA, declared that when we preach on Sunday that Jesus told us to welcome, we will use our hands and voices on Monday to make sure it happens.
- We have a broken system regarding immigration, refugees and asylum-seekers. To declare ourselves a sanctuary

church body is to say that we seek to provide concrete resources to assist the most vulnerable who are feeling the sharp edges of this broken system.

- Being a sanctuary denomination is about loving our neighbors. While we may have different ideas about how to fix this broken system and may have different ways of loving our neighbors, our call to love our neighbor is central to our faith.
- Being a sanctuary denomination will look different in different contexts. It may mean providing space for people to live; providing financial and legal support to those who are working through the immigration system; or supporting other congregations and service providers. The ELCA churchwide organization cannot mandate or direct our congregations and ministries to respond in specific ways. Each must work out what this means for them in their context.
- While we don't yet know the full scope of the work that this declaration will open for the ELCA, we do know that our faith communities are already doing sanctuary work. Sanctuary for a congregation may mean hosting English as a Second Language (ESL) classes, marching as people of faith against the detention of children and families, providing housing for a community member facing deportation, or, in some of our congregations, having thoughtful conversations about what our faith says about immigration. All of these are a step closer to sanctuary in our faith communities and sanctuary in our world for people who must leave their homes.
- Except for our members whose ancestors were here before European settlement or others who were forced to come to the U.S. against their will, the ELCA is an immigrant church. Our decades-long work with immigrants and refugee is how we practice our faith in the world. Lutherans started Lutheran Immigration and Refugee Service (LIRS), one of the nine refugee resettlement agencies in the U.S.
- At our 2016 Churchwide Assembly, we also committed to walking alongside Central American children and families fleeing their communities by passing the AMMPARO strategy (Accompanying Migrant Minors with Protection, Advocacy, Representation and Opportunities).
- Through the AMMPARO strategy, we are also working through our global partners in Central America to alleviate the conditions that cause people to migrate. We support organizations and faith communities that work with deported migrants in Central America and advocate for the humane treatment of immigrants in Mexico. In the U.S., we have a network of 151 welcoming and sanctuary congregations that are committed to working on migration issues and a welcome for immigrant communities. The church also has five sanctuary synods (our regional structures), all of which do work with immigrants, refugees and asylum-seekers.

- In baptism, we are brought into a covenantal relationship with Jesus Christ that commits us to strive for justice and peace in all the earth. Following the example of Martin Luther, we believe that advocacy is a crucial expression of baptismal identity. As a church, we have advocated for stopping the detention of children and families for decades. We have spoken out against family separation, sought a pathway to citizenship for community members that have lived in the U.S. for many years, and have taken steps to address the root causes of migration in a way that honors the humanity in people who must flee.
- Being a sanctuary denomination means that we, as church together, want to be public and vocal about this work. At the same time, we will have conversations about what sanctuary means with many of our members and discern future action and direction. For us, welcoming people is first and foremost a matter of faith which impacts how we live out all our vocations in God's world, including our political life.



Sharon Josephson Elected Vice President of NW Minnesota Synod

On the third ballot, more than 400 Rostered Leaders and Lay Voting Members representing churches of the Northwestern Minnesota Synod of the Evangelical Lutheran Church in America (ELCA) have elected Sharon Josephson of Detroit Lakes, MN, as Synod Vice President.

Josephson received 214 votes; John Wold of Underwood, MN received 208 votes. 212 Votes were needed to be elected Vice President.

"I am honored to have been elected vice president of the Northwestern Minnesota Synod of the ELCA. The Holy Spirit is working in amazing ways as we elect a new bishop today," Josephson said. "I promise to support and help the leadership of the synod as we move into the adventure of God's plan for the future."

Josephson is a member of Trinity Lutheran Church in Detroit Lakes, where she has served in a number of roles on committees and as a 3-term congregational president. She has also served as the chair of the Bishop Election Committee, a member of Synod Council, and a 2-time

Churchwide Assembly voting member. She is a retired Senior High School social studies teacher and is a former congressional staff member for Congressman Collin Peterson.

The Vice President is a lay person who chairs the Synod Council, and in the event of a bishop's death, resignation or disability, would consult with the Presiding ELCA Bishop to convene the Northwestern MN Synod Council to arrange for the conduct of duties of the bishop until a new bishop shall be elected or until the bishop can resume full performances of the duties of office.

Salem of Rural Stephen Holds Closing Worship Service

On Saturday, June 22, Salem Lutheran Church of rural Stephen, MN, was packed with members and friends for its closing service of worship. After 136 years of mission and ministry, the members of Salem had decided last January that it was time to say "Mission Accomplished."

The celebration of Salem's life coincided with their annual Midsummer Picnic and Sale, a tradition treasured by Swedish immigrants like those who founded Salem in 1883.

Over Salem's long history, the congregation raised up at least four pastors and two deaconesses. Three of the "children" of Salem who became pastors of the ELCA were present and participated in the service of closure: retired Pr. Peter Schmidt of West Fargo, retired Pr. Marlene Anderson of Moorhead, and Pr. Janna Kontz who serves with Hospice of the Red River Valley in Fargo. Each of them offered greetings to the worshipers and helped lead the liturgy for "retiring" the key places of Word and Sacrament ministry: the Pulpit, the Altar, and the Baptismal Font.

Greetings from several former pastors were read by Marilyn Grandstrand, president of the congregation, and two additional former pastors were present. Pastor George and Nancy Johnson, who now live in southern Ontario, reminisced

on their time of service at Salem. Pastor Curtis and Darlene Matz had come all the way from Fairbanks, AK, to recall their years of service (Darlene served as a Synodically Authorized Minister alongside her husband) when Salem was part of the Four Crosses parish.

Bishop Larry Wohlrabe preached the sermon, based on the celebration's theme text, John 15:1-11 (the Vine

and the branches). He also led the closing liturgy before the final ringing of the church bell.

During the service Ms. Grandstrand announced the final distribution of assets of the congregation. She remarked that initially some members thought that all the assets should simply go to the Salem Cemetery Association, which is taking over the land, the building and its upkeep. But other members



thought the assets should all go toward mission endeavors in the wider world.

The members of Salem compromised, leading to the following distribution plan for Salem's remaining financial assets:

\$10,000 (in a Certificate of Deposit) will go to the cemetery association, earmarked for use in the future, when its board determines it is time to raze the church building.

The remaining cash assets, after all bills are paid, will be distributed as follows:

- 30% to the Northwestern Minnesota Synod of the Evangelical Lutheran Church in America;
- 10% to Pathways Bible Camps;
- 20% to the synod's Next Generation Fund (the synod endowment fund);

- 20% to the NW MN Synod Fund for Leaders Endowment;
- 20% to the Salem Cemetery Association.

Ironically, this distribution of remaining assets reflected an intriguing tidbit from Salem's history. Way back in 1886, when members of Salem needed to raise the "huge sum" (back then!) of \$100 to pay the workmen who were erecting Salem's church building, an appeal for contributions went out to all members of Salem. Times were tough economically though, and they struggled to come up with the entire \$100. But then Salem received a gift "out of the blue" of \$54.29 from the Alexandria District of the Augustana Lutheran Church—Salem's "synod" back in the 1880s! In other words: just as Salem in 1886 received crucial funds from the wider church, so now in 2019 Salem is giving gifts to the wider church, to help other congregations in their mission and ministries.

Rest Stop God Moment

One concept that has stuck with me from my time as a confirmation guide is "God moments." We were often challenged to be on the lookout for God moments in our lives during the week. On July 19, God was not just in a moment; rather, He was encircling my family and holding in the palm of His hand the family of Jim at a South Dakota rest stop.

My family was traveling toward the Badlands and Black Hills of South Dakota in a rented RV. Only an hour after leaving Sioux Falls our first morning, I suddenly felt a need to stretch. (Although I had broken my hip and injured my knee this winter and was still struggling with pain and

stiffness, I was normally able to sit a few hours at a time.) We pulled into the next rest area and planned to visit the little roadside chapel there; however, on the sidewalk was a woman on her phone who seemed quite distraught. We stopped to see if she was okay, and she said her husband, Jim, was in a diabetic coma and she was on with an emergency dispatcher.

Keith went to assess the situation and sprinted to the RV for some juice. He motioned the girls and me away from the picnic shelter where Jim lay, as he didn't want the girls to witness what was unfolding, nor did we want to invade the family's privacy. While Keith tried to assist Jim's daughter, a hospice nurse, with CPR, the girls and I wept, held each other, and prayed for the ambulance to arrive, for healing, and for comfort for their family.

When the on-call EMTs finally arrived, the girls in brightly colored T-shirts ran to the parking lot to direct the ambulance to Jim's location. Keith and the EMTs got Jim onto the gurney but, sadly, it was too late. Jim's wife rounded the corner of the shelter with vacant eyes and told me he had passed away. All I could do was embrace her, cry with her, and let her know that we would be praying for her. I knew that although Jim was with God, for the moment, those left behind would feel alone.

As we got back into the RV, I was reminded that we may be asked to be God's hands, feet, and heart in even the most unlikely places. This "eternal rest" stop experience reinforced our common humanity, grieving for a stranger purely because he is a fellow child of God.

God moments occur around us every day but often go unnoticed...until a God event jolts us out of our complacency.
